

# **Privacy Policy**

At Sporting Equals we are committed to protecting the personal data we are provided with by our clients, associates and other contacts.

We have updated our Privacy Notice in line with the new General Data Protection Regulation (GDPR). This Privacy Notice explains what happens to any personal data that you provide to us or that we collect from you.

We do update this Notice from time to time and when we do we will let you know. However please do view this Notice regularly.

We do not store credit card details and if we do in the future, we will not share your data with any third party unless we have your consent to do so for a clear legitimate purpose that we have explained to you.

### Information We Collect

We may collect and process the following data about you:

- 1. Information about your use of our site including details of your visits such as pages viewed and the resources that you access. Such information includes traffic data, location data and other communication data. (See use of cookies below)
- 2. Information provided voluntarily by you, for example when you register for our newsletters. You provide this data to allow us to communicate with you and share the information you are asking and expecting to receive from us.
- 3. Information that you provide when you communicate with us by any means. We will only keep this data if we need it and only use it to continue our service to you. You can ask us what data we hold on you and request for this data to be deleted at any time.

## **Use of Cookies**

Cookies provide information regarding the computer used by a visitor. We may use cookies where appropriate to gather information about your computer to assist us in improving our website.

### **Use of Your Information**

We use the information that we collect from you to connect with you more appropriately. In addition to this we may use the information for one or more of the following purposes:

- 1. To provide information to you that you request from us.
- 2. To collect statistical data to better understand the impact Sporting Equals is having on third parties.



3. To provide information to you about Sporting Equals that may be of interest to you. Such additional information will only be provided where you have consented to receive such information.

# **Disclosing Your Information**

We will not disclose your personal information to any other party other than in accordance with this Privacy Notice and in the circumstances detailed below:

- 1. Where we are legally required by law to disclose your personal information.
- 2. To further fraud protection and reduce the risk of fraud.
